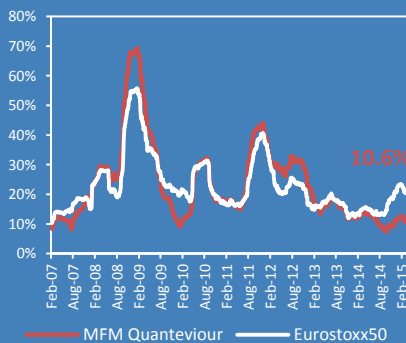
Strategy

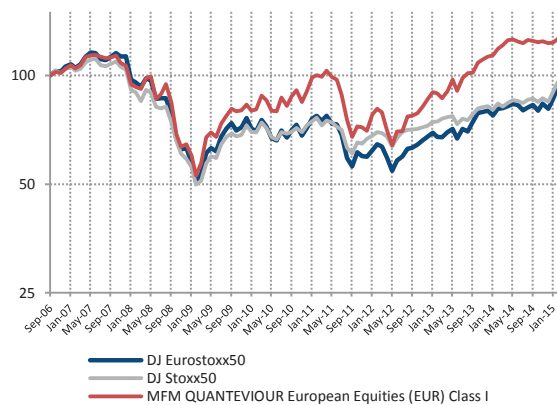

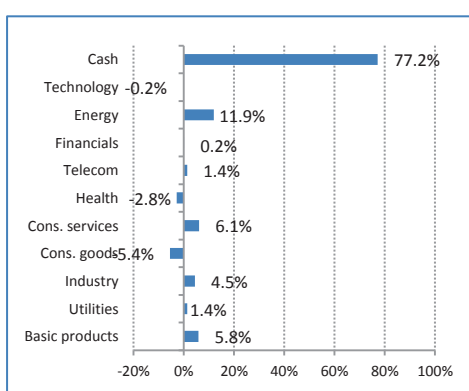

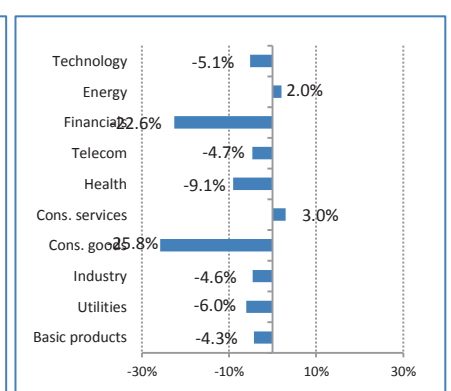
