## Strategy

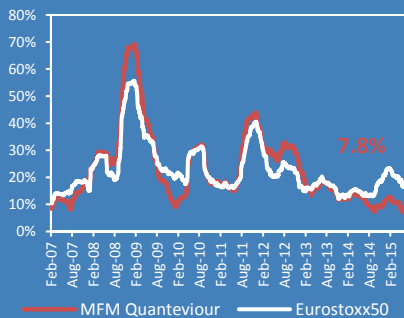

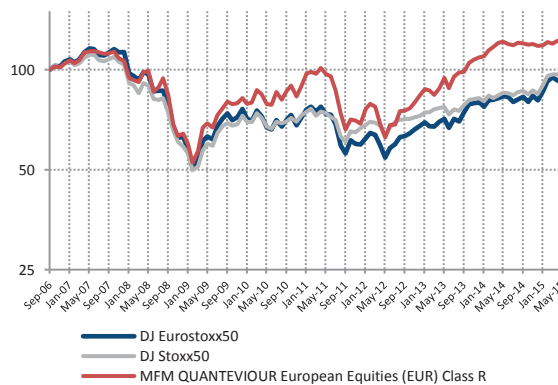

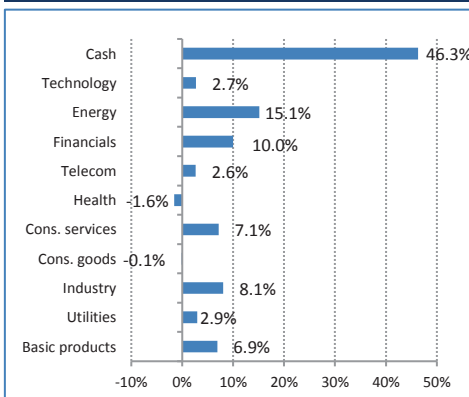

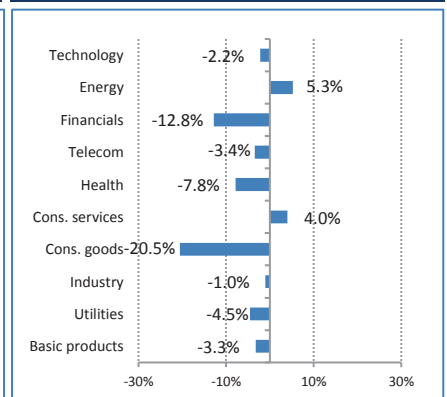
