## Strategy

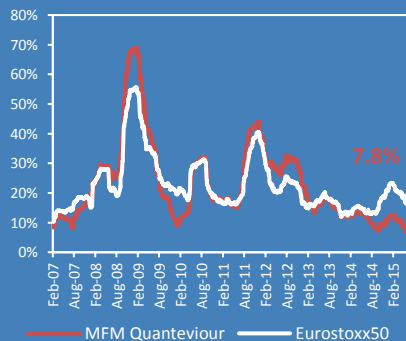

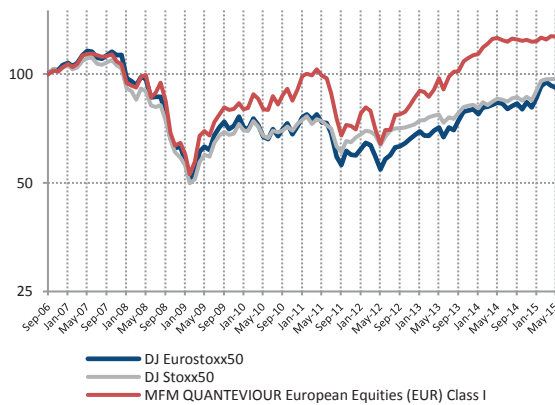

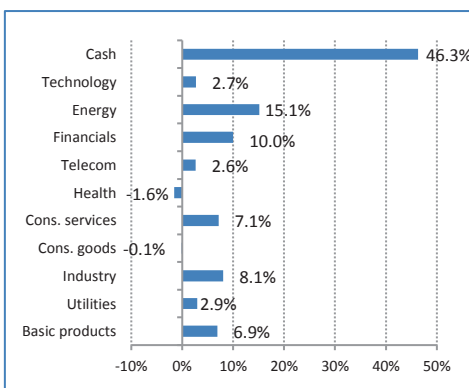

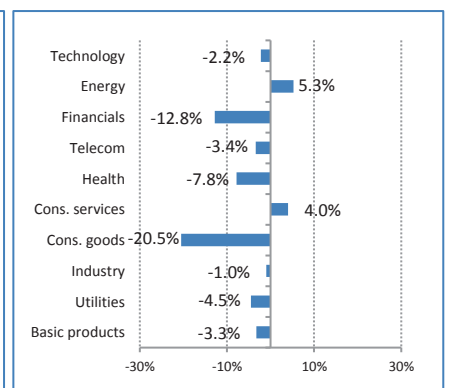
