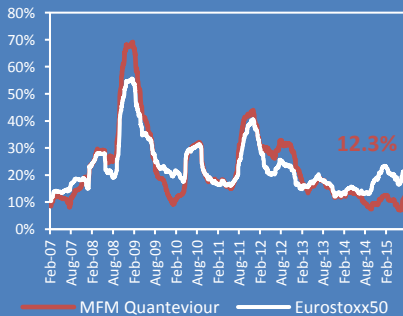
Strategy

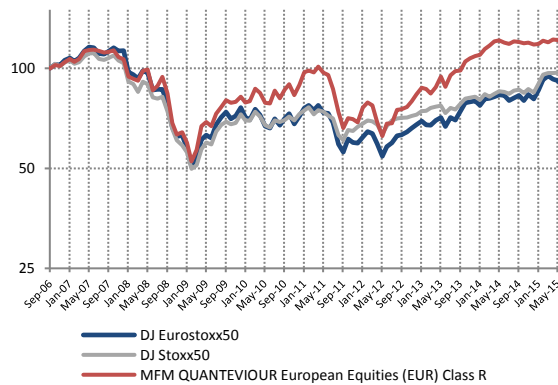

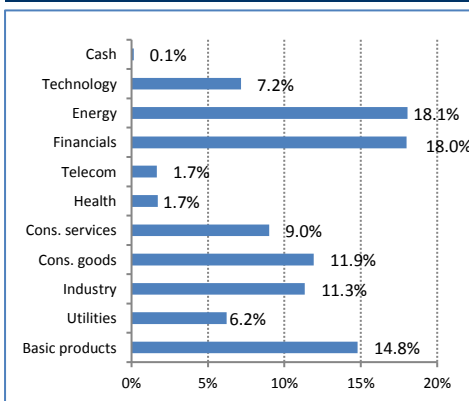

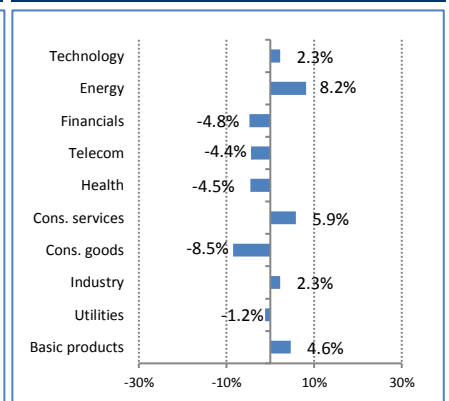
