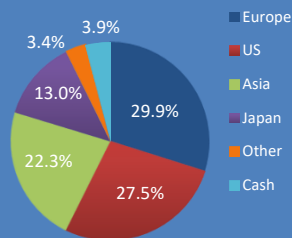

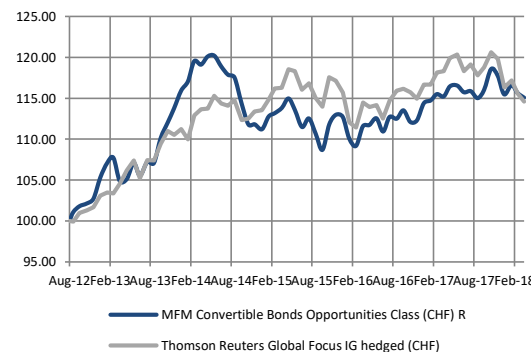

**Historical NAV (reinvested distributions)**



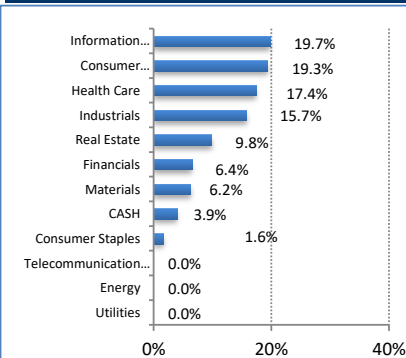

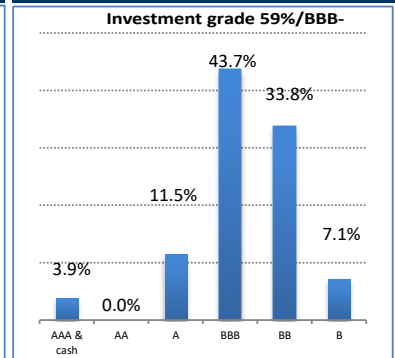
