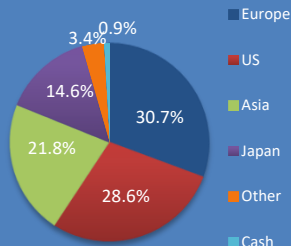

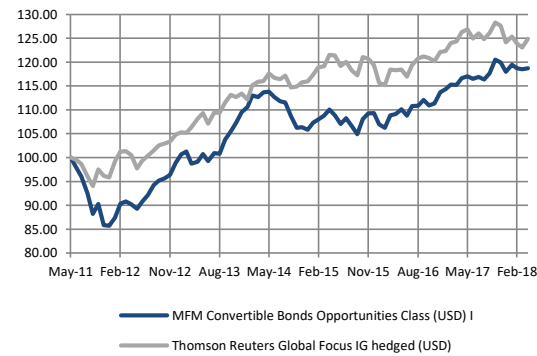

Historical NAV (reinvested distributions)



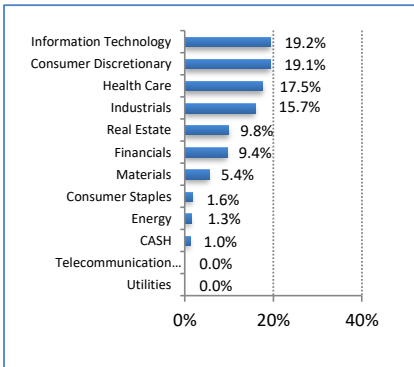

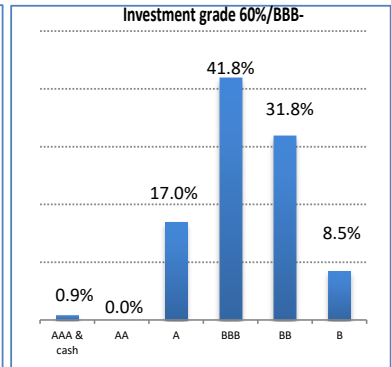
